IHONC cannot guarantee any official game assignments throughout the course of the hockey season. As recognized Independent Contractors, all officials are responsible to maintain their availability in the web-based assignment system utilized by IHONC. IHONC may take several factors into consideration when assigning officials including but not limited to skill level, availability, dependability, attitude, perceived conflict of interest, exposure, and location. All officials that do not have any previous game officiating experience working a sanctioned USA Hockey travel program must participate in IHONC's mentor program before being assigned games without a mentor. IHONC's mentor program can be reviewed in detail by visiting our web site (ihonc.org) and selecting the Mentor Program link. After graduating from our Mentor Program, game assignments will be dependent upon your level of ability as evaluated by your mentor, and your availability to accept appropriate level assignments.
